# End User License Agreement and Limited Product Warranty for Teledyne Optech Products

**IMPORTANT - READ CAREFULLY:** This End-User License Agreement (this "EULA") is a legal agreement between the Licensee and the Teledyne Optech company from which you acquired the software, either Teledyne Optech Incorporated or Teledyne Optech, Inc. (hereinafter referred to as "Optech"). This EULA is for the Optech software product(s) (the "Software") with which this EULA is delivered, which includes the computer software, whether delivered as a single part or as a collection of parts ("Components").

All of the contents of the files, Optech services and other media with which this EULA is provided, including, but not limited to, any templates, online/electronic documentation, and all copies thereof, as well as any upgrades, modified versions and updates to the Software now or hereafter licensed to the Licensee by Optech are also subject to the terms and conditions of this EULA.

Any third party software provided with the Software that is associated with a separate EULA is licensed under the terms and conditions of that EULA.

By issuing a Purchase Order against the Quotation issued by Optech, or by downloading, installing, accessing, copying, or otherwise using the Software, the Licensee acknowledges that it has read this EULA and agrees to be bound by the terms of this EULA. If the Licensee does not agree to the terms and conditions of this EULA, the Licensee must not download, install or use the Software, and must immediately return the Software and all copies to Optech.

## 1. GRANT OF LICENSE

- 1.1. Optech grants the Licensee the rights described in this EULA provided that the Licensee complies with all the terms and conditions set forth herein.
- 1.2. Optech grants Licensee a perpetual, non-exclusive, non-assignable license to use the Software solely in connection with the use and operation of Optech systems.
- 1.3. Optech may provide some Components of the Software in the form of text files (Configuration Files) for the purpose of allowing the user to modify the Software's behavior or appearance. The Licensee may modify Configuration Files installed with the copy of the Software for which the Licensee is licensed. Optech will have no support, warranty, indemnity or obligations relating to, and assumes no liability for, these modifications or any effects they may have on the Software or the products generated using the Software.

# 2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS

2.1. The Licensee may not use any Internet-based services associated with the Software in any manner that could damage, disable, overburden, or impair such services. The Licensee may not attempt to gain unauthorized access to any service, account, computer systems or networks associated with the Internet-based services.

# 3. RESERVATION OF RIGHTS AND OWNERSHIP

3.1. Optech reserves all rights not expressly granted to the Licensee in this EULA. The Software is protected by copyright and other intellectual property laws and treaties. Optech owns the title,

copyright and other intellectual property rights in the Software. The Licensee is granted a license only to use the Software for the purposes and subject to the terms and conditions of this EULA. This EULA does not grant the Licensee any rights to the intellectual property in the Software, including but not limited to any copyright, trademarks or service marks, of Optech or Teledyne Technologies Incorporated.

3.2. Title to the medium containing the Software delivered to the Licensee shall remain with Optech or the applicable third party.

#### 4. USER RESTRICTIONS AND LIMITATIONS

- 4.1. The Licensee may only install and use as many copies of the Software as the licensing permits.
- 4.2. The Licensee may not use the Software other than in connection with and for use with Optech systems.
- 4.3. The Licensee shall not reverse engineer, decompile, or disassemble the Software or otherwise attempt to derive the source code from all or any part of the Software.
- 4.4. The documentation that accompanies the Software is licensed for internal, non-commercial reference purposes only. It cannot be re-sold, redistributed, or otherwise transmitted externally.
- 4.5. The Licensee shall not transfer the Software or license to another Company or entity.
- 4.6. The Licensee shall not use, copy, modify, or transfer the Software, or any copy, modification, or merged portion, in whole or in part, except as expressly provided for in this EULA.
- 4.7. The Licensee shall not use, copy, modify or transfer Components of the Software for the purpose of combining or using them with a different product from the one the Licensee is licensed to use.
- 4.8. The Licensee shall not use the Software to develop any derivative works or any functionally compatible or competitive software
- 4.9. This EULA applies to all Components of the Software.
- 4.10. The Licensee shall not circumvent the licensing, keys, and/or files.
- 4.11. The Licensee shall not sell, rent, lease or lend, or otherwise transfer the Software to others or use the Software for commercial time-sharing, rental or service bureau use.
- 4.12. The Licensee shall not use the Software in any way other than as expressly permitted under this EULA.
- 4.13. The Licensee shall not remove any copyright or other proprietary rights notices on any label of disks or other storage media containing the Software but instead shall ensure that the Optech's copyright and proprietary rights notices are not disabled and remain conspicuously displayed on the screen of users during the set-up and start-up routines of the Software.

- 4.14. The Licensee shall not publish, distribute, transfer or disseminate any information related to the evaluation, performance, analysis, or comparison of the Software with any other product(s) without Optech's prior written consent.
- 4.15. The sample and demo data set(s) and related script(s) delivered with some Software (Sample Data) are provided solely for the purpose of instructing the user on how to use the Software. The Sample Data are not to be redistributed, resold, or used in a production solution without Optech's prior written consent.

## 5. CONSENT TO USE OF DATA

5.1. The Licensee agrees that Optech and its affiliates may collect and use technical information gathered as part of the product support services provided to the Licensee, if any, related to the Software. Optech may use this information solely to improve its products or to provide customized services or technologies to the Licensee and will not disclose this information in a form that personally identifies the Licensee.

#### 6. ADDITIONAL SOFTWARE/SERVICE

6.1. This EULA applies to updates, supplements, or any other additions to the Software that Optech may provide to the Licensee after the date the Licensee obtains the initial copy of the Software, unless they are accompanied by separate terms and conditions. Optech reserves the right to discontinue Internet-based services provided to the Licensee or made available to the Licensee through the use of the Software.

#### 7. TRADEMARKS

7.1. Optech's trademarks, logos, service marks, tradenames, or any names closely resembling the same are not to be adopted or used in any manner without the prior written consent of Optech. Any additional trademark information is given in the "Trademark and Copyright" information included in the Software installation directory, the Software documentation, or the Software "About" box.

#### 8. THIRD PARTY COMPONENTS

8.1. Additional licensing information for third party components used by the Software is provided in the Software installation directory. Upon Optech's request, the Licensee shall provide written confirmation that it has complied with its obligations in this Section.

#### 9. TERMINATION

- 9.1. Without prejudice to any other rights, Optech may terminate this EULA if the Licensee fails to comply with the terms and conditions of this EULA. In such event, the Licensee must immediately destroy all copies of the Software and all of its Components. Upon Optech's request, the Licensee shall provide written confirmation that it has complied with its obligations in this Section.
- 9.2. Licensee may terminate this EULA at any time by destroying all copies of the Software and all of its Components and providing Optech with written notice certifying such destruction.

- 9.3. Termination by Optech or Licensee shall not affect the Licensee's liabilities accrued up to the date of termination.
- 9.4. The Licensee acknowledges that any failure to comply with the terms and conditions of this EULA will give rise to immediate irreparable damage to Optech. Notwithstanding anything to the contrary in this EULA, Optech shall have recourse to all available remedies at law or equity in relation to, and may obtain immediate and injunctive relief to prevent or mitigate, the breach or threatened breach of the obligations set out under this EULA. The Licensee further agrees that the covenants contained herein are reasonably necessary for the protection of legitimate business interests of Optech and are reasonable in scope and content.

#### 10. NO WARRANTIES

- 10.1. Optech provides the Software, support services (if any), and any related documentation as is and with all faults and, except as expressly granted by Optech in writing elsewhere, hereby disclaims to the maximum extent permitted by law all other warranties and conditions, whether express, implied or statutory. This disclaimer includes, but is not limited to, any warranties of merchantability, fitness for a particular purpose, reliability or quality, accuracy or completeness, workmanship, or lack of viruses or negligence.
- 10.2. The entire risk arising out of selection of the Software, use or combination of the Software with other software and/or equipment, installation, use or performance of the Software remains with the Licensee. As Optech is not in a position to verify the data produced by its clients, data generated or processed by the Software is the Licensee's responsibility. The Licensee is solely responsible for verification of any such data and for ensuring that all appropriate and necessary precautions are in place prior to using the data in any way. Optech is not responsible for the quality of data generated or produced by the Software, and is not responsible for damage to or loss or impairment of the data or for any injury (including death), damage or loss of any kind that may be caused, directly or indirectly, by use of or reliance upon the data.

# **11. EXCLUSION OF CONSEQUENTIAL AND OTHER DAMAGES**

- 11.1. To the maximum extent permitted by law, in no event shall Optech be liable for any special, incidental, punitive, indirect, or consequential damages whatsoever, including, but not limited to damages for loss of use, loss of revenues, loss of anticipated profits, loss of confidential or other information, loss of privacy, business interruption or loss of business, or for any other pecuniary or other loss whatsoever, howsoever arising, even if Optech has been advised in advance of the possibility of such damages.
- 11.2. Optech's total liability to the Licensee arising from or related to this EULA is limited to no more than the amount paid by the Licensee to Optech hereunder. To the extent that this limitation of liability conflicts with any other provision herein, such provision shall be regarded as amended to whatever extent required to make such provision consistent with this clause.
- 11.3. As used herein, the term "Direct Damages" means those damages which arise naturally or ordinarily and/or can reasonably be expected to result from a breach of this EULA or any agreement in which the EULA is incorporated.

11.4. As used herein, the terms "Indirect Damages" and "Consequential Damages" mean damages which do not flow directly or immediately from a breach of this EULA or any agreement in which the EULA is incorporated, but only from a consequence or result of such breach.

#### 12. MISCELLANEOUS

12.1. If for any reason a court finds any provision or portion of this EULA to be unenforceable, the remainder of this EULA will continue in full force and effect. Optech may modify or amend this EULA at any time by providing the Licensee notice of the modification or amendment, and by installing, copying or using the Software after any such modification or amendment, the Licensee agrees to be bound thereby.

## **13. GOVERNING LAW**

13.1. This EULA is written and construed in the English language and its interpretation in any judicial or arbitration proceedings shall be in accordance with the meaning of the words and phrases in Canada, and performance of the Parties is construed and governed in accordance with the laws of the Province of Ontario, Canada, excepting its laws and rules relating to conflict of law. Neither (a) the United Nations Convention on Contracts for the International Sale of Goods, (b) the 1974 Convention on the Limitation Period in Contracts for the International Sale of Goods (hereinafter referred to as the "1974 Convention"), nor (c) the Protocol Amending the 1974 Convention done at Vienna, Austria, on April 11, 1980, apply in any manner to the interpretation or enforcement of this EULA.

#### **14. DISPUTES AND ARBITRATION**

14.1. The Parties shall attempt to resolve any dispute, controversy, or claim arising under or relating to this EULA, including its interpretation, performance, or termination. If the Parties are unable to resolve such dispute, either Party may refer the dispute to arbitration. The arbitration shall be conducted in English and in accordance with the ADRIC Arbitration Rules of the ADR Institute of Canada, Inc., which shall administer the arbitration and act as appointing authority. The arbitration, including the rendering of the decision and/or award, shall take place in Vaughan, Ontario, Canada, and shall be the exclusive forum for resolving the dispute, controversy, or claim. The arbitrator shall make the final determination as to any discovery disputes between the Parties. Examination of witnesses by the Parties and by the arbitrator shall be permitted. A written transcript of the hearing shall be made and furnished to the Parties. The cost of this transcript shall be borne equally by the Parties. The award and/or decision of the arbitrator shall (a) state the reasons upon which the award is based and (b) shall be final and binding upon the Parties. The expense of the arbitration, including, but not limited to, the award of attorneys' fees to the prevailing Party, shall be paid as the arbitrator determines. Both Parties waive their right to any appeal under any system of law. The award shall be enforceable before any court of competent jurisdiction upon the application to such court by either Party. The arbitrator shall be instructed that no award may be made of consequential, punitive or multiple damages.

14.2. The Licensee consents to the operation of this Section and irrevocably waives its sovereign immunity from all actions or proceedings in connection with any arbitration or post-arbitral enforcement.
